## Reuniões científicas

1 a 5 de fevereiro - 2015

### XII Congresso Luso-Afro-Brasileiro em Ciências Sociais (CONLAB), Universidade Nova de Lisboa, Portugal

Os Congressos Luso-Afro-Brasileiros têm sido, desde a sua 1.<sup>a</sup> edição em 1990, um dos mais importantes encontros de cientistas sociais e das humanidades dos países de língua oficial portuguesa. Mas também um espaço pluri e transdisciplinar, reagrupando intelectuais de todas as disciplinas das ciências sociais e das humanidades, num esforço de promoção da reflexão e partilha de produção científica, almejando simultaneamente a criação, consolidação e internacionalização da produção científica em língua portuguesa.

Com o objetivo por um lado, da busca da institucionalização de parcerias no domínio da pesquisa em ciências sociais e humanas nos países de língua portuguesa e, por outro, de constituir-se num espaço de exploração e promoção de ideias e projetos relevantes para o desenvolvimento da paz, da democracia e da inclusão num contexto global de profundas e rápidas transformações.



O tema do XII CONLAB, o primeiro a realizar-se após a criação, em Salvador da Bahia, da AICSHLP (associação científica de apoio, promoção e desenvolvimento das ciências sociais e humanas em língua portuguesa), propõe ser um catalisador de uma reflexão que recupere a trajetória dos onze congressos realizados, apontando os ganhos que as ciências sociais e humanas dos Sete tiveram e as pontes construídas para a sua consolidação enquanto áreas de saber e a busca de um maior protagonismo no espaço global da produção conhecimento, ainda marcado por clivagens epistemológicas, teóricas e políticas condicionando, quando não subalternizando o fazer ciência em língua portuguesa.

O XII Congresso de Ciências Sociais e Humanas em Língua Portuguesa será organizado em duas partes: a primeira consistirá no evento científico subordinado ao tema “Imaginar e Repensar o Social: Desafios às Ciências Sociais em Língua Portuguesa, 25 anos depois”. Esta parte estará organizada em sessões plenárias (conferências) e paralelas (mesas coordenadas e Grupos de Trabalho).

Membros associados e a comunidade de pesquisadores em ciências sociais e humanas dos Sete países falantes do português e demais pesquisadores desses espaços são convidados a participar do evento.

A segunda parte consistirá da dimensão institucional destinada à realização das reuniões estatutárias dos órgãos da AICSHLP, destacando-se a reunião da Assembleia Geral, com a eleição de novos membros dos órgãos da Associação a tomarem posse em 2016.

## **Conable Conference “Exile, Deportation, and Forced Labor in Colonial Africa”, Rochester, New York**

Deportation and exile have long, complex, and intertwined legacies in colonial Africa. From the forced removal of kings, queens, chiefs, and commoners, to the displacement of entire clans from their homelands, or the coerced expatriation of political dissidents and their families, deportation and exile operated as two edges of a single imperial weapon. British, French, German, Portuguese, Belgian, Spanish, Italian, and South African colonial regimes all employed exile and deportation—often coupled with threatened or real forced labor—to end dynasties, to silence rival chieftaincies, to forestall millennial religious movements, and to facilitate the wholesale seizure of agricultural and pastoral lands for industrial enterprises or white settler farmers.

As part of the fourth Conable Conference in International Studies, the 2015 Conable African Studies Symposium at the Rochester Institute of Technology, will exaerole of deportation, exile, and forced labor in colonial African in interdisciplinary comparative perspective.

We seek to understand the uses and implications of exile, deportation, and forced labor as political and legal tools throughout the African continent, ranging from their roles in the incipient 19<sup>th</sup> century “colonial encounter” to the expansion of mature colonialism in the 20<sup>th</sup> century, to their employment to forestall nationalist, pan-Africanist, and independence movements. We welcome papers employing disciplinary, interdisciplinary, or cross-disciplinary perspectives.

Abstracts for the Symposium up to 500 words clearly identifying the argument, method of delivery, evidentiary basis, disciplinary/interdisciplinary nexus, or analytical framework, and site of research, study, or project accompanied by a two-page CV identifying the proposer(s) by name, affiliation, address, and email, should be submitted online by **December 15, 2014**.

## **International Seminar “Culture, Politics and Labor in Southern Africa”, Unicamp, Brasil**

Scholars have long ago pointed out that Africa is not a homogenous continent. Even so, references to the “History of Africa” continue, often drawing upon a selective highlighting of colonial policies and experiences that effectively separates Africa into English, Portuguese, French, German (etc.) spheres of colonization. “Culture, Politics and Labor in Southern Africa” is an international seminar that proposes a shift in this approach.

On the one hand, it seeks to emphasize the perspectives of Africans - not just an “African perspective,” but the points of view of peoples who saw, dealt with and resisted the presence of Europeans (including during the periods that the established historiography calls pre or post colonial). As a result, it proposes on the other hand an analysis of Southern Africa: an extensive area in which Bantu peoples predominated (and still do).



This international seminar also seeks to deepen the academic ties between the Department of History/Harriet Tubman Institute at York University and the Centro de Pesquisa em História Social da Cultura of the Universidade Estadual de Campinas (UNICAMP).

Last, but not least, this international seminar further provides an opportunity to discuss the conditions of the production of research in Brazil related to Southern Africa. As such, we are also interested in presentations that focus on sources available for research and/or concentrate on methodological questions that enable us to use them.

## 6th European Conference on African Studies (ECAS-6), Paris, France

Following on Lisbon in 2013, the Sixth European Conference on African Studies (ECAS-6) will take place in Paris at the Sorbonne. The co-organisers are IMAF (Institut des mondes africains) and LAM (Les Afriques dans le monde).

The principal theme of ECAS 6 is “Collective Mobilisations in Africa: Contestation, Resistance, Revolt”. This theme, however, is not exclusive. The scientific committee will also consider panel proposals on other themes, associated with emergent and more classical fields of study alike.

ECAS requires all accepted panels to be open to paper proposals through the website: panels should not be organised as ‘closed’ sessions. Delegates may only give one paper. They may, however, also convene one plenary session, panel, or roundtable, or be a discussant in one plenary session, panel, or roundtable.

## Symposium “Landscapes, Sources, and Intellectual Projects in African History: Rethinking Historical Evidence and its Interpretation”, University of Birmingham (UK)

What types of evidence, data, and sources can we use to expand our knowledge of the African past? How can different types of evidence be critically analysed - be they landmarks on African landscapes or faded texts produced by authors unfolding specific intellectual and political projects? These are some of the questions that have animated the work of Dr. Paulo Fernando de Moraes Farias for five decades.

On 12-14 November 2014 the Department of African Studies and Anthropology (DASA) and Centre of West African Studies (CWAS) of the University of Birmingham (UK) will host a symposium aimed at confronting these questions and speaking to issues that have been central to Dr. De Moraes Farias' scholarship.

To open the symposium, Dr. De Moraes Farias has accepted to give the third Fage Lecture on the 12 November at 5pm. His lecture will be followed by a reception and the two subsequent days will feature workshop-style panels and plenary sessions.


We invite submissions of panels and/or papers focusing on any of the themes listed below or generally related to Dr. De Moraes Farias' research.


### "Life Not Worth Living". Nigerian Petitions Reflecting an African Society's Experiences During World War II

Studies of the Second World War have not particularly focused on the contribution of African societies or the impact of the war on their lives.

The biggest problem faced by the colonial administration was the rising cost of living that became pronounced during the war. The war forced the British to restructure the local economy in order to ensure that the Nigerian population produced the necessary commodities needed to support the British war effort.

This book presents unusual but critically important primary sources left by ordinary Nigerians in the form of petitions and supplications to British officials during the war. Written by individuals living in rural and urban areas in Nigeria, these unique documentary sources reflect local reactions and responses to imperial war policies.

### A Grammar of Mbembe


A grammar of Mbembe is a description of a little studied Jukunoid language which is spoken in the borderland of Nigeria and Cameroon.

Present-day structures of different dialects are described and discussed with respect to diachronic developments. It is based on extensive fieldwork, but also takes into consideration previous work on Mbembe and other Jukunoid languages.

The main topics in the chapters on the noun phrase and the verb and simple sentence structures are nominal classification and number marking based on Ablaut phenomena and tone, argument structure, and serial verb constructions.

The remaining chapters cover phonology, complex structures, information structure and requesting information, and other word classes. This is complemented by example texts and a word list in the appendix.


### Human Rights and Development. Legal Perspectives from and for Ethiopia




## Afro-European Trade in the Atlantic World The Western Slave Coast, c. 1550- c. 1885

From 1550 to colonial partition in the mid-1880s, trade was key to Afro-European relations on the western Slave Coast (the coastal areas of modern Togo and parts of what are now Ghana and Benin). This book looks at the commercial relations of two states which played a crucial role in the Atlantic slave trade as well as the trade in ivory and agricultural produce: Hula, known to European traders as Grand Popo (now in Benin) and Ge, known as Little Popo (now in Togo).

Situated between the Gold Coast to the west and the eastern Slave Coast to the east, this region was an important supplier of provisions for Europeans and the enslaved Africans they purchased. Providing a detailed reconstruction of political and commercial developments in the western Slave coast, including the transition from the slave trade to legitimate commerce, this book also reveals the region's position in the wider trans-Atlantic trade network and how cross-cultural partnerships were negotiated.







#### PN 4 | Thirsty, hungry and no power?: African resources in a global world

Water, food and energy are fundamental to African development.

However, several crucial issues need to be addressed.

Are African resources used to meet African needs or are they being exploited to satisfy the needs of other actors facing food and energy insecurity?

#### PN 5 | Small farms under stress play a huge role for Africa : smallholder agriculture and emerging global

Widespread poverty as well as food and income insecurity plague Africa's dominant smallholder agriculture.

Paradoxically, the very people who mainly depend on agriculture are not able to secure their own food and nutrition needs.

Today, three-quarters of Africa's malnourished children and the majority of people living in absolute poverty are found among the smallholder farmers who are key to the development of the continent.

#### PN 6 | Commanders for good and bad : alternative post-war reconstruction and ex-commanders in Liberia

Contrary to the general conviction, collaboration with ex-commanders and their informal networks can actually promote postwar stability.

When former generals are integrated into the post-conflict societal structure as brokers of socio-economic service and mediators between governing elites and former combatants, they can help to provide security and stability.

In the case of Liberia their direct access to ex-combatants makes them suitable for distributing jobs, money, food, scholarships and other resources.





This new and revised edition of *A Concise History of South Sudan* was revised by Avelino Androga Said, Yosa Wawa, Anne Farren and Anders Breidlid. All chapters were revised and a new chapter on the period from the referendum in 2011 to the period after independence has been added.

When the first edition was published in 2010 it was the first history book of its kind in the now South Sudan. This first edition was primarily intended for secondary schools in South Sudan, but the book proved to arouse great interest to many other South Sudanese both inside South Sudan as well as in the diaspora.

The book may be of interest to students, academicians, politicians and civil society groups such as churches and youth and women's groups.


## Revista de Ciências Sociais | Dossier temático “O Trabalho em África” (vol. 46, n.º 02, jul./dez, 2015)
