Rwanda under the RPF:Assessing Twenty Years of Post-Conflict Governance, School of Oriental and African Studies (SOAS), University of London

In the nearly two decades since the 1994 genocide, Rwanda has experienced substantial political, social and economic change, due mainly to the ambitious policies of the Rwandan Patriotic Front (RPF).

Analyses of RPF rule, especially since Paul Kagame became President in 2000, vary greatly, with some scholars characterising it as a visionary form of post-conflict governance and development and others as a destructive brand of national social engineering and the steady entrenchment of authoritarianism.

While some commentators describe this period as one of major political reform and innovation, others emphasise continuities between the RPF and previous Rwandan regimes, especially in terms of the centralisation of power.


This conference and the subsequent special issue of the Journal of Eastern African Studies (JEAS) will bring together a broad spectrum of commentators to debate the nature of Rwandan politics under the RPF and its impact on the post-genocide reconstruction process, regional relations and the wellbeing of everyday Rwandans.

Rather than simply commemorating the twentieth anniversary of the genocide, the conference and special issue will analyse the nature and effects of the RPF's particular brand of governance, including in shaping Rwanda's future political, social and economic trajectories.

The conference will be hosted by the JEAS, and the Centre for African Studies and the Department of Politics and International Studies at SOAS.

The conference organisers and editors of the special issue are Jason Mosley, research associate at the African Studies Centre, Oxford (and managing editor, JEAS), and Phil Clark, lecturer in comparative and international studies, SOAS.

Following the conference, those presenters will be expected to submit a draft article of maximum 8,000 words by **18 October 2013** for consideration for the special issue, which will bepublished in the first half of 2014.



Joint conference presentations and joint articles would be extremely welcome. (Scholars interested to contribute to the special issue but unable to participate in the conference, please contact Jason Mosley.)

The Nordic Africa Institute and the Refugee Law Project, Makerere University, Uganda will organize a workshop in Kampala on "Armed Forces and Conflict Dynamics in the Great Lakes Region: Local, National & Regional perspectives".

An exploratory workshop

Due to their crucial importance for regional and local conflict dynamics, the functioning and activities of armed actors in the Great Lakes Region merit greater scholarly attention.

In particular the economic and identity-dimensions of armed activity, as well as their relationship to models of national and regional governance, remain poorly understood, as the focus has thus far been on a limited range of issues related to "conflict minerals" and "ethnic conflict".

We welcome contributions that are based on empirically grounded research on the role of armed forces in peace and conflict dynamics, whether government armies, rebel groups, paramilitaries or militia.

We are specifically interested in approaches that firmly situate armed actors within their civilian environment and study the wider social networks that link armed and non-armed actors.

Authors will receive notice of the final disposition of their submission by **August 15, 2013**. By accepting participation, authors commit themselves to submitting a final paper of 8000-10.000 before **10 October 2013**.

As sub-Saharan Africa's third largest economy, one of its major oil producers, and key regional player, Angola should have elicited a considerable amount of academic work. However, difficulties of access on account of the war that lasted from 1975 until 2002, unfamiliarity with the language and the discouragement of research resulted in serious gaps that are only beginning to be addressed.

This means that crucial dimensions of this pivotal African state, as well as their relevance for comparative research, are either misunderstood or virtually unknown. Other than the decades of delay in scholarly research per se, the academic structures taken for granted in the study of contemporary Africa are only now being developed, whether in terms of frequent academic encounters, research collaborations, or institutional dialogue.


This conference, which is the follow-up to a successful event held in Oxford in July 2011, will again bring together social scientists and historians to discuss the study of modern and contemporary Angola.

After taking a little snuff and then smoking daka together, they are ready to pass on. Time is no object with the African aborigines.



A History of the British Medical Administration of East Africa, 1900-1950

Missing from the abundant literature on the history of British East Africa had been an evaluation of the British medical administration and its relation to the conduct of East African colonial governments. Beck's account of the modernization and development of scientific health services in Kenya, Uganda, and Tanganyika during the first half of the twentieth century not only filled that void, it also provided additional insight into the political, social, economic, and cultural aspects of the colonies.

Included in her study of this complex system of colonial medical services are discussions of the changing and conflicting objectives of the colonial personnel, other influences on medical policy such as tribal traditions and varieties of climates within the region, disease control, and public health education of the Africans. She also considers the impace of World War I on the medical administration and presents her general observations on medical services in developing countries.

Food Security, Safety Nets and Social Protection in Ethiopia

Hunger and food shortages have been endemic in rural Ethiopia for countless generations; nevertheless, it was not until the mid-1970s, following the fall of the imperial regime and its replacement by the military government, the Derg, that food security became a concern in public policy discourse, and a variety of program initiatives were put in place to tackle the problem. Since then there has been increased awareness of the complex causes of food shortages and a growing determination on the part of decision-makers to bring to an end the blight of hunger and malnutrition.

This book stems from the LEAFS (Linking Emergency Assistance with Food Security) project initiated in 2007 as a collaborative project between Wageningen University Disaster Studies Department and Bahir Dar University Department of Disaster Risk Management and Sustainable Development.


The Concentration Camps of the Anglo-Boer War

A Guerra Colonial constitui um momento fundador da realidade sociopolítica do Portugal contemporâneo.
