We are specifically interested in approaches that firmly situate armed actors within their civilian environment. By accepting participation, authors commit themselves to submitting a final paper of 8000-10.000 before **10 October 2013**.

SOCIUS | II International Conference on Angola: New Directions in Angolan Research, St Peter's College, Oxford University

As sub-Saharan Africa's third largest economy, one of its major oil producers, and key regional player, Angola should have elicited a considerable amount of academic work. However, difficulties of access on account of the war that lasted from 1975 until 2002, unfamiliarity with the language and the discouragement of research resulted in serious gaps that are only beginning to be addressed.

This means that crucial dimensions of this pivotal African state, as well as their relevance for comparative research, are either misunderstood or virtually unknown. Other than the decades of delay in scholarly research per se, the academic structures taken for granted in the study of contemporary Africa are only now being developed, whether in terms of frequent academic encounters, research collaborations, or institutional dialogue.

This conference, which is the follow-up to a successful event held in Oxford in July 2011, will again bring together social scientists and historians to discuss the study of modern and contemporary Angola.

Organized by the Department of Politics and International Relations, Oxford University and the Research Centre in Economic and Organizational Sociology (SOCIUS) at ISEG/UTL (the School of Economics and Management of the Technical University of Lisbon).





These languages have undergone important changes in their lexicon, phonology, morphology, and syntax as a result of over a thousand years of Arabic influence.

The social situation of Berber-Arabic language contact is similar all over the region: Berber speakers introducing Arabic features into their language, with only little language shift going on.

Moreover, the typological profile of the different Berber varieties is relatively homogenous.

The comparison of contact-induced change in Berber therefore adds up to a study in typological variation of contact influence under very similar linguistic and social conditions.


Words and objects, missionary bodies, problematic converts, and the utopian imagination are discussed, as well as how the Zulus made use of (and ignored) the stations.

The majority of the Norwegian missionaries had become theological cheerleaders of British colonialism by the 1880s, and Ingie Hovland argues that this was made possible by the everyday patterns of Christianity they had set up and become familiar with on the mission stations since the 1850s.



The project compared the performance of growth and development of four pairs of countries in Southeast Asia and Sub-Sahara Africa during the last sixty years. It tried to answer the question how two regions with comparable levels of income per capita in the 1950s could diverge so rapidly.

Why are there so many Asian tigers and not yet so many African lions? What could Africa learn from Southeast Asian development trajectories?






The South African Communist Party

As part of the ethical approach, the book also reviews the main issues related to gendersensitive reporting, in view of the significant role the media have to play in gender education.


In an age of information overload, over-exposure to a hyper-mediated culture and the rise of user-generated content, journalists increasingly strive to remain relevant. The temptation to use lower standards, resort to sensationalism and even paycheck journalism is strong. Such examples of unethical practice can only further undermine the credibility of a profession which purports to act as a watchdog, a Fourth Estate.


