Memory, Power, and Knowledge in African Music and Beyond, Cape Coast, Ghana, 2014, University of Cape Coast, Ghana

This conference seeks to explore, both from historical and contemporary perspectives, the nexus between memory, power, and knowledge in the music of Africa and its various diasporas. These explorations encompass the history and politics of sound archiving and scholarly practices as much as intersections of memory, power, and knowledge in musical performance itself.

The contexts within which we would like to examine this broader field include, but are not limited to, the realms of popular culture, politics, religion, as well as education. Throughout history, music has been a crucial means in the representation of power and status as well as the negotiation of individual and collective identities. As a repository of knowledge, musical practice often functions as a form of social memory, which we understand not as a static entity but as a dynamic field within shifting power relations on both the local and translocal level.

Media technology has, over more than a century now, played an important role in the reconfiguration of this nexus, and particularly the rise of electronic media in recent years has changed and accelerated its dynamics. Surprisingly little research has been undertaken on festivals in and featuring Africa in any disciplinary field.





Framing a Radical African Atlantic







The Battle for Syria, 1918-1920





It goes on to relate how the French arrived, late, to take over territory allocated to them in the Sykes-Picot Agreement of 1915, territory which included both Syria and Lebanon; how influenza had a severely detrimental impact on the allied advance; and how the Turks regrouped, successfully, north of Aleppo, and prevented further allied advance.



Homosexuality was and still is thought to be quintessentially 'un-African'. Yet in this book Chantal Zabus examines the anthropological, cultural and literary representations of male and female same-sex desire in a pan-African context from the 19th century to the present.

Reaching back to early colonial contacts between Europe and Africa, and covering a broad geographical spectrum, along a north-south axis from Mali to South Africa and an east-west axis from Senegal to Kenya, here is a comparative approach encompassing two colonial languages (English and French) and some African languages.

Out in Africa charts developments in Sub-Saharan African texts and contexts through the work of 7 colonial writers and some 25 postcolonial writers. These texts grow in complexity from roughly the 1860s, through the 1990s with the advent of queer theory, up to 2010.

Forced convict labor provided the Portuguese with solutions to the growing criminal population at home and the lack of infrastructure in Angola and Mozambique.

In Convict Labor in the Portuguese Empire, Timothy J. Coates examines the role of large numbers of convicts in Portuguese Africa from 1800 until 1932.

This work examines the numbers, rationale, and realities of convict labor (largely) in Angola during this period, but Mozambique is a secondary area, as well as late colonial times in Brazil.

This is a unique, first study of an experiment in convict labor in Africa directed by a European power; it will be welcomed by scholars of Africa and New Imperialism, as well as those interested in law and labor.

The 2012 Claude Ake Memorial Lecture: As Uganda comes closer to full scale commercial production of its recently discovered oil resources, the state has much work to protect its economy from possible negative effects. Although much of the literature regarding oil globally, as well as in Uganda, paints a rather pessimistic picture, Dr. Pamela Mbabazi provides a set of alternatives, looking at oil as an opportunity rather than a curse.

The African diaspora is arguably the most important event in modern African history. African Local Knowledge & Livestock Health. Diseases & Treatments in South Africa

Understanding local knowledge has become a central academic project among those interested in Africa and developing countries. In South Africa, land reform is gathering pace and African people hold an increasing proportion of the livestock in the country. Animal health has become a central issue for rural development. Yet African veterinary medical knowledge remains largely unrecorded. This book seeks to fill that gap. It captures for the first time the diversity, as well as the limits, of a major sphere of local knowledge.

Beinart and Brown argue that African approaches to animal health rest largely in environmental and nutritional explanations. They explore the widespread use of plants as well as biomedicines for healing. While rural populations remain concerned about supernatural threats, and many men think that women can harm their cattle, the authors challenge current ideas on the modernisation of witchcraft.

O Projeto Africano de interpretação de conferência e de tradução propõe-se promover a implantação no continente africano de ciclos de formação em interpretação de conferência, tradução e de interpretação « de serviço público » (na função pública, hospitais, tribunais, etc.). O processo de integração regional em África teve por consequência uma multiplicação do número de organizações regionais e internacionais em África e, por conseguinte, do número de reuniões, conferências e documentos a traduzir.

Graças ao Projeto Africano foram criados centros de excelência para a formação nestas disciplinas em todo o Continente. Estes centros fornecem cursos de formação de dois anos, ao nível de Mestrado, e concedem um diploma de Mestrado Pan-africano em interpretação de conferência e tradução. Esta iniciativa pretende dar resposta à crescente procura de profissionais nestas áreas em África e situa-se no prolongamento de outras ações que visam promover a formação de uma nova geração de intérpretes e tradutores na Europa, na Ásia e nos Estados Unidos.

A decisão de lançar o Projecto Africano foi tomada pelos chefes dos serviços linguísticos das principais organizações internacionais (ONU, Comissão Europeia, Parlamento Europeu, União Africana, Secretariado ACP, Banco Africano de Desenvolvimento...), refletida na Declaração de Gigiri, surge no seguimento da apresentação de um relatório intitulado «Language matters», da autoria do consultor Noël Muylle, a pedido do Secretariado-Geral das Nações Unidas.
